





In response to your letter dated 23rd November 2000, we would like to inform the ECT Secretariat about the status of Bosnia and Herzegovina's ratification of the Energy Charter Treaty and PEEREA.

On 13th October 2000 Presidency of Bosnia and Herzegovina, after previously obtained approval of the Parliamentary Assembly of BiH (Decision of PA No 20/00 from March 2nd 2000.), adopted two Decisions on ratification of the Energy Charter Treaty and PEEREA. These decisions shall be announced in Official Gazette of BiH and after that, according to ratification procedure, Ministry of Foreign Affairs of Bosnia and Herzegovina will officially submit instruments of ratification to the Government of the Portuguese Republic, Depositary of the Treaty.

Copies of the Decisions of BH Presidency accompanied with their unofficial translation are attached.
