



A Embaixada de Sua Majestade Britânica apresenta os seus cumprimentos ao Ministério dos Negócios Estrangeiros e tem a honra de se referir à sua Nota Verbal 2004/184

O Reino Unido aplicou provisoriamente o Tratado da Carta de Energia no Reino Unido e em Gibraltar na altura da assinatura. Porém, o Governo de Gibraltar informou posteriormente o Governo Britânico que não pretendia ratificar o Tratado considerando que nessa altura o Tratado não teria qualquer efeito prático no território. Gibraltar não foi portanto incluído no instrumento de ratificação do Reino Unido relativo ao Tratado, depositado a 17 de Dezembro de 1997.

O Governo de Gibraltar tenciona contudo emitir legislação destinada a ratificar o Tratado em data posterior. O Governo de Sua Majestade Britânica está presentemente em contacto com o Governo de Gibraltar com vista à elaboração da legislação necessária.

A Embaixada de Sua Majestade Britânica aproveita esta oportunidade para renovar os protestos da sua mais elevada consideração.


